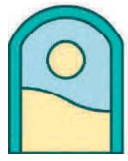

Instructions

Please complete with the candidate and attach to the final ISST Application ("Appendix D").

Purpose

The purpose of this "step-by-step" checklist is to help advisors prepare trainees to apply for ISST membership and to avoid common problems that arise with certification. Problems may occur when Appendix D is not completed properly or when the applicant submits Appendix D before they have met requirements for certification.

Checklist Structure

To make it easy to follow, numbers on this checklist correlate with the numbers on Appendix D.

1. Curriculum Vitae

- The applicant has attached their CV to appendix D.

2. Training

- All professional training, licensure, and development activities have been completed as reported.
- The applicant has indicated whether they are a Jungian Analyst and IAAP Member.
Note: Appendix F contains modified requirements for qualified Jungian Analysts.

3. Personal Sandplay Process

- Check the name of the Personal Process Therapist (PPT):
- The PPT was a certified member or teaching member of ISST at the time that the personal process was completed (required).
- The applicant has completed their personal process, including all information listed on Appendix D (e.g., date started, date completed, number of sessions, number of trays)?

Check all sections of Appendix D. Does the PPT's name appear as a supervisor/consultant or final case reader?

- Yes (If you checked "yes" here, advise applicant to obtain required exception letter*.)
- No

*Unless a formal exception has been granted by the Member Society or ISST Exceptions Committee (for individual member applicants), the Personal Process Therapist cannot have a dual relationship with the candidate by providing supervision or by serving as a reader for the final case papers. If applicable, please submit the letter of exception, explaining the circumstance and rationale for exception, with Appendix D.

- The advisor has signed this section to acknowledge verification.

4. Sandplay Training / Education

The advisor reviews the original training certificates and ensures that applicant has met required training hours for ISST (100 total / 60 total for qualified Jungian Analysts). The advisor also checks with the Member Society and ensures that the applicant has met training requirements for their Member Society—which may exceed ISST hours and may have minimum requirements in specific content areas such as sandplay fundamentals, Jungian theory, etc.

Note: Once verified by the advisor, the actual certificates do not need to be included with Appendix D. However, the applicant is advised to keep copies of their training certificates.

- Applicant has completed and properly recorded required ISST training hours on Appendix D.
- Applicant has completed and properly recorded required Member Society training hours on Appendix D.
- The advisor has signed this section to acknowledge verification.

5. & 6. Seminar / Symbol Papers

The advisor verifies that each Seminar (Symbol) Paper has been read and approved by an ISST Teaching Member. One of the papers must contain clinical sandplay material.

Note: Ideally, the reader for the second seminar paper should be a different person than the reader of the first seminar paper. However, this is not currently specified in the ISST Rules of Procedure. Member Societies may also have additional guidelines for readers.

- Paper 1 has been approved by ISST Teaching Member
- Paper 1 has been verified with advisor signature.
- Paper 2 has been approved by ISST Teaching Member.
- Paper 2 has been verified with advisor signature.
- One of the seminar papers contains sandplay case material. (Note: The seminar/symbol paper for IAAP Jungian Analysts must contain clinical material.)

7. Supervision

The advisor reviews supervisor documents and verifies that applicant has completed all required supervision hours for ISST and their Member Society.

- The applicant has completed a minimum of 80 hours of total supervision (40 total for Jungian Analysts).
- Supervision has occurred with at least two different ISST Teaching Members. (If not, obtain required exception letter or complete additional supervision with another supervisor.)
- None of the supervisors were the applicant's personal process therapist. (If so, advise applicant to obtain required exception letter. See item 3 above.)
- The applicant has completed at least 30 hours of individual supervision (15 hours for Jungian Analysts).

- If applicant submits a maximum of 50 group supervision hours (maximum of 25 hours for Jungian Analysts), the applicant has presented their own case material for at least 20% of the group supervision hours that they are applying toward certification.
- The applicant has met the requirements of the Member Society for supervision.

8. Final Case Paper

- All three case readers have been approved by ISST and appear on the list of final case readers.
- At least one case reader is from a different Member Society from their own. None of the case readers are the applicant's Personal Process Therapist.
- None of the case readers are listed as a supervisor/consultant. None of the case readers are the applicant's advisor.
- The advisor has verified that the applicant has obtained permission from the client to use their material under a pseudonym for the final case study. Note: To protect client confidentiality, the actual permission form should not be included with the application.
- Summary comments from all three case readers are attached to Appendix D.
- The advisor has indicated date of final approval and signed this section to acknowledge completion of all requirements for final case.

9. Verification (final page of Appendix D):

- The applicant has signed/dated final page.
- The advisor has signed/dated final page.

Member Society (MS) Approval

- For those applicants who are from a country with a MS: The MS has reviewed and approved the applicant's Appendix D.
